Moreover Environment/Health & Safety a dept. under Jafza conducts periodical inspection of the warehouse to ensure things are intact and prescribed safety norms are complied with.
- •Insurance Policy cover: In addition to the above we have a separate Insurance Policy protecting all the goods kept in our Warehouse against Theft /Fire /Damages etc. –Kindly be informed that we have no history of any theft or pilferage ever since the inception of the Warehouse.
- •Security Arrangements: Jebel Ali Free Zone Authority keeps a vigil on the Warehouse day and night and have Security arrangements in place to ensure that there are no thefts etc. There are Security guards who keep a watch round the clock.
